

City of Beverly Hills 2021-2022 End of Year Scorecard

The first year of the two-year, 2021-2022 state legislative session, ended on September 10, 2021, at midnight. The Governor then had until midnight on October 10, 2021 to sign or veto the legislation. During the past year, the City took a position on 59 pieces of legislation, supporting 31 bills, opposing 22 bills, supporting if amended three bills, support – seek amendments one bill, and opposing unless amended two bills.

Of the 31 bills the City supported, 11 were signed into law by the Governor (35 percent); none were vetoed by the Governor; 19 are two-year bills and can still be heard in 2022; and one is a proposed constitutional amendment which can still be heard in the second year of the two-year state legislative sessions.

Of the 22 bills the City opposed, 11 were signed into law (50 percent), two were vetoed by the Governor, and nine are two-year bills, which can still be considered by the state legislature in 2022.

Of the three bills the City supported if amended, two were signed into law and the other bill can still be heard in the second year of the two-year state legislative session.

The one bill the City supported and was seeking amendments on was vetoed by the Governor on October 8, 2021.

Finally, of the two bills the City opposed unless amended, one bill was vetoed by the Governor. The other bill is a two-year bill and may be taken up by the state legislature in 2022 for further consideration.
